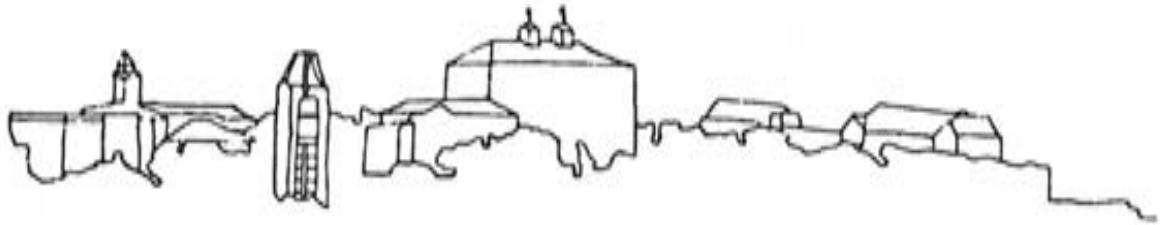

Welcome to the University of Kansas for the Kansas Conference in Clinical Child Psychology. Situated atop Mount Oread, KU is the home of the Jayhawks, but not of Dorothy and Toto. It was a camping ground on the Oregon Trail and the final resting ground for "Free Stater" victims of a massacre during the Civil War. Lawrence is or was the residence of John Brown, Langston Hughes, William Burroughs, James Naismith, Comanche, and half of Albert Einstein's brain.

The University has a long tradition of scholarly contributions in child and developmental psychology through the Department of Human Development and Family Life and in clinical psychology through the Department of Psychology. In the last three years, an interdepartmental effort has developed the Clinical Child Psychology Program utilizing faculty and resources in both departments while bringing in new faculty and students for the graduate training program in the specialty. This Conference is a project of the Clinical Child Psychology Program; we hope you will become familiar with our activities and assets while you are here.

The Conference is co-sponsored by the Section on Clinical Child Psychology (Section I of the Division of Clinical Psychology, American Psychological Association). The Section publishes the *Journal of Clinical Child Psychology*, provides programming at the annual convention of the American Psychological Association, and supports a number of task forces and activities on professional issues in child and family mental health services. Membership information will be available at the Conference displays.

Additional financial support for this year's Conference is provided by the College of Liberal Arts and Sciences of KU within which the Clinical Child Psychology Program resides. We gratefully acknowledge the substantial College support. The KU Office of Academic Affairs and the KU Division of Continuing Education have also provided subsidies to the conference. The Conference fees would be much higher without these contributions, so we particularly thank these units for assistance.

Registration

All Conference attendees, including presenters, guests, and participants must register. A conference badge is required for admission to all conference sessions, meetings, and meals.

Continuing Education Credits

We will be able to provide certificates of attendance for those needing Continuing Education Credits. We are approved by the American Psychological Association to offer continuing education credit for psychologists. CE credit can be earned for participation in the Topical Sessions and Plenary Addresses. The maximum amount of CE credit available for this conference is 11. To receive credit, participants must complete evaluation forms at the conclusion of each particular session (provided in the Big Eight Room where sessions are held). At the end of the session, participants should return their evaluation forms in order to receive the CE certificate for that session. PLEASE NOTE: Evaluation forms will not be given out at a later date. Each participant will be responsible for getting in their evaluation form immediately at the close of a session. Objectives

We intend for attendees at this Conference to attain the following objectives:

1. Provide up-to-date information on research and practice in clinical child psychology and mental health services for children and families.
2. Provide specific learning experiences targeted to topics in: externalizing disorders, internalizing disorders, therapy and interventions, assessment, prevention, violence and youth, pediatric psychology, and psychotherapy effectiveness.
3. Provide opportunities for productive interactions between researchers and practitioners.

Book Display

Eating

On Friday and Saturday mornings, the Conference will provide Continental Breakfasts, 8:00 to 9:00 in the Ballroom of the Kansas Union. During the mornings (Friday & Saturday) and afternoon (Friday), we will take refreshment breaks. Lunches are provided as part of your registration fee for both Friday and Saturday (we hope you will then take time to read the posters on display). There will be receptions on Thursday (in the Haskell room of the Ramada Inn starting at 7:30pm) and on Friday in the Adams Alumni Center, a block from the Union (starting at 5:00pm). Information is
