Welcome

Welcome to the University of Kansas for the *1996 Kansas Conference in Clinical Child Psychology*. KU is the home of the Jayhawks, but not of Dorothy and Toto.

Founded in 1854 by anti-slavery groups, Lawrence, Kansas quickly became a hotbed of "Free State" supporters. Undaunted by the burning of their town by Quantrill's raiders in 1863, Lawrence residents welcomed the establishment of a state university atop Mount Oread in 1865. Lawrence has been the residence of many notables over the years including: John Brown, Langston Hughes, William S. Burroughs, James Naismith, Comanche, and half of Albert Einstein's brain.

The University of Kansas has a long tradition of scholarly contribution to child and developmental psychology through the Department of Human Development and Family Life and in clinical psychology through the Department of Psychology. In the last five years, an interdepartmental effort has developed the Clinical Child Psychology Program utilizing faculty and resources in both departments while bringing in new faculty and students for the graduate training program in the specialty. This conference is a project of the Clinical Child Psychology Program and we hope you will become familiar with our activities and assets while you are here.

This conference is co-sponsored by the Section on Clinical Child Psychology (Section 1 of the Division of Clinical Psychology, American Psychological Association).
